NEW CHAIR APPOINTED TO THE BOARD OF MONTRÉAL INVIVO: MS. CHRISTINE LENNON TAKES OVER

Montréal, June 29, 2023 – Frank Béraud, CEO of Montréal InVivo, is pleased to announce the appointment of Christine Lennon, General Manager of Incyte Biosciences Canada, as Chair of the Board of Directors. Ms. Lennon has been active on the Board prior to being appointed as Chair.

Christine Lennon became the first General Manager and employee for Incyte in Canada, and is responsible for developing Incyte's medical, regulatory and commercial strategy in Canada. Prior to joining Incyte, Christine was President and CEO of Epigene Therapeutics, a spinout of Neomed, now Admare Bioinnovations. Prior to this, she spent eight years at Novartis, and also held senior positions at Neurochem, Shire (now Takeda), BioChem Pharma and the Industrial Research Assistance Program of the National Research Council of Canada (NRC).

Christine has also worked as an advisor to life sciences startups and served as an executive-in-residence and advisor to the healthcare venture capital teams at Business Development Bank of Canada (now Amplitude Ventures) and at Caisse de Dépôt et Placement du Québec.

From biotech to pharmaceuticals to corporate finance, Christine has in-depth knowledge of the sector and also of our organization, as she has already been involved on some of our committees. Christine Lennon sits on several boards of directors. She also serves as a judge and mentor for McGill's Dobson Centre for Entrepreneurship and McGill's Desautels MBA School, and was named Healthcare Businesswomen Association Luminary in 2022.
